

NOTICE PURSUANT TO PERSONAL DATA PROTECTION ACT, 2010

The Personal Data Protection Act 2010 (“the Act”) is an Act that is passed by the Malaysian government to regulate the processing of personal data in a commercial transaction. This Notice is issued pursuant to the provisions of the Act and serves to inform you of how your personal data is being processed and your rights under the Act. Further, we hereby seek your consent for the processing of your personal data.

This personal data notice applies to any person whose personal data is processed by or on behalf of ECM Libra Group Berhad (hereinafter referred to as “ECMLG”, “our”, “us” or “we”).

1. Subject to the relevant laws, including the guidelines, rules, regulations and codes issued by the relevant authorities, ECMLG may use your personal data for the following purposes (“Purposes”):
 - a. To process applications for products and services;
 - b. To enable us to discharge our contractual obligations;
 - c. To evaluate and monitor provision of services;
 - d. To understand data subjects’ needs and offering products and services to meet those needs and providing ongoing information about our events, products and services;
 - e. To enable the resolution of a concern or complaint;
 - f. For evaluation and due diligence purpose;
 - g. For research and development of products and services;
 - h. To enable us to discharge our duties and obligations under the relevant written law, rules, regulations, guidelines and/or codes or any arrangement with any relevant authorities or bodies authorised by the relevant local or foreign laws; and
 - i. For any other purpose that is incidental or ancillary or in furtherance to the above Purposes.
2. The personal data processed by us may include data collected from data subjects such as your name, contact details, email address, occupations, assets and income, the relevant services provided to you and any other personal data required for the Purposes set out in paragraph 1 above.
3. Your personal data may be collected from various sources, including information you have provided us, information from third parties and information in the public domain.
4. You may at any time hereafter make inquiries, complaints and request for access to, or correction of, your personal data or limit the processing of your personal data by submitting such request to us via post or email as set out below.

We wish to highlight that it is essential for you to provide us with your personal data as requested from time to time and consent to the continuous processing (including collecting, storing, holding and retaining) of your personal data (including personal data already provided prior to the date of this Notice), and if you choose not to supply us with your personal data or if you are no longer agreeable to us processing, retaining, holding or storing your personal data, we may not be able to carry out the purpose for which you have provided us the personal data or properly perform or discharge our obligations to you.

6. Your personal data will be kept confidential but subject to relevant laws, your personal data may be disclosed to the following for the Purposes set out in paragraph 1 above:
- a. our parent company, subsidiaries, related and associated companies;
 - b. any person that is required to comply with the relevant law, regulations, rules and codes;
 - c. our licensees, co-organisers of events, business partners and service providers;
 - d. the Securities Commission, Bank Negara Malaysia, the Police, the Malaysian Anti-Corruption Commission, Companies Commission of Malaysia, Registrar of Societies and other supervisory, governmental or regulatory authority;
 - e. any relevant authority or body;
 - f. any stock or derivatives exchange, clearing house, securities depository authorised by the relevant laws;
 - g. auditors, professional firms or entities and any other person which ECMLG may deem necessary for its business purpose.

notwithstanding that any such persons may be outside Malaysia, for any of the above Purposes or any other purpose for which your personal data was to be disclosed at the time of its collection or any other purpose directly related to any of the above Purposes or where such disclosure is required or authorised by law or by the order of a court.

7. Your personal data may be stored or transferred to locations and systems outside Malaysia.

We are committed in ensuring the confidentiality, protection, security and data capture accuracy of your personal information made available to us. In this regard, it is important that all personal information submitted by you are, and shall remain, accurate, not misleading, updated and complete in all aspect.
